Section 3. Comparative Data

This section provides overall means for given comparators (e.g., division, department) alongside the mean values for a given course. Note that the comparators are calculated by pooling together all individual student survey responses (e.g., student responses for all of the courses in a department are pooled together and the departmental mean responses calculated from that). The provided comparators are thus a measure of the 'average' student experience for a unit or division; they are not a measure of the 'average' course in a unit or division. This calculation has the effect of giving large courses more 'weight' in the calculation of the comparator means. The effect of this on the calculated comparator varies depending on the relative proportion of large or small courses within a unit or division. As such, the departmental and divisional comparative mean values provided on course evaluations should not be regarded as an absolute and definitive benchmark.

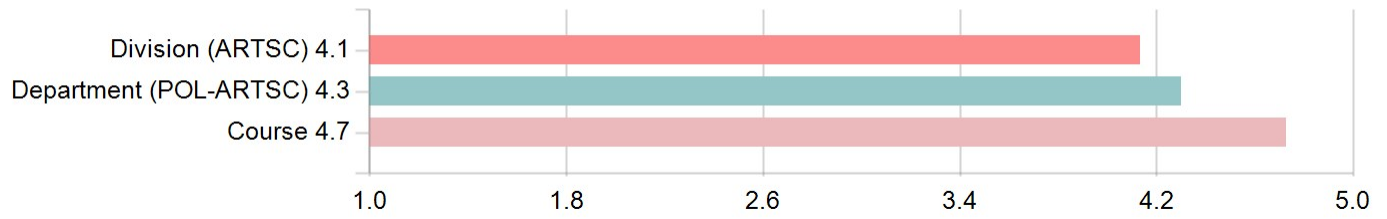
For example, if a department offered only two courses, one with 1000 students who all answered 3.5 and the other with 10 students who all answered 4.5 (so that the means would be 3.5 and 4.5 respectively), then the departmental mean provided on the course evaluations would be 3.51 since the calculation would be $[(3.5 \times 1000) + (4.5 \times 10)] / 1010 = 3.51$ and not $(3.5 + 4.5) / 2 = 4$.

Professor Soedirgo was amazing! She tried so hard to make this class interactive and different from any other class (with different assignments)! I loved this class and made me excited to learn more about a region I hardly get to learn about!

Professor Soedirgo was an engaging, knowledgeable, approachable, and considerate instructor. She made course material and instructions very clear. She delivered lectures in creative and effective ways. Her lectures were much more enjoyable than other online courses taken so far. I appreciate her efforts to be flexible and accommodate the various challenges of virtual learning at this time. She has been an inspiring academic as well as a wonderful person to learn from. One suggestion: I wish the live seminar discussions were less "structured." While pre-set questions made discussions more organized (and, I suspect, easier to facilitate), they felt a little rigid at times. I sometimes wanted to freely bring up questions with peers or respond organically to others' thoughts but felt constrained by the parameters of the question. It was like we were all lining up to give our answer for one test question without being able to fully engage with one another about the week's materials freely. (But I do understand that this was necessary due to time constraints.) Altogether a wonderful experience in POL388 with Dr. S! I learned so much and found a region that I enjoy studying!

Prof Soedirgo made the leaning environment very accepting and interesting. I always looked forward to coming to class. She made the best of the online classes and this was one of my favourite courses at U of T!

The professor was very welcoming and created a great learning environment. I thought the class was well organized and I appreciate the well-made lectures. The only problem was participation. The class was short and made it hard to speak when so many others had a lot to say. U of T is losing a good professor to Amsterdam.

The weekly seminar discussions were engaging and a positive experience. The textbook and assigned articles were interesting. I appreciated the ability to revise and resubmit the paper.

Everything was clear in terms of course content, what was expected of us during the seminar portion and the asynchronous portion.

I loved this course. I'm always in shock that there are so few Southeast Asian (or any Asian courses) in general within the POL field. Not only was she incredibly understanding and knowledgeable, she was also able to create a space where all the students felt safe to discuss all view points.

Here are some specifics I liked about her course:

- In some of her asynchronous lectures/podcasts, she would invite speakers. These speakers were the authors of our assigned readings! This was very interesting, and gave us the inside scoop on their work!
- Her lectures always began with a brief historical recount of the specific region. This was very helpful, as most of us had not taken a course within this area.
- She offered many ways to participate in class (especially if you weren't in a specific time zone). This was done via Kahoot, Flip Grid, and the staggered tutorial times.
- Her teaching was concise and straight forward. She was honest when did not know the answer, and would open the floor to discussing said questions.
- Her asynchronous and synchronous sessions were always on time.
- She always responds very quickly to emails and questions.

It was very fun to learn through podcasts and videos with graphics than simply through the run of the mill lecture style. It made the content much more interesting and because it was interesting it was more memorable so I found myself making connections about themes more easily.

Assignments received good levels of feedback and there were opportunities provided for improvement. The option to write 3 critical summaries was also helpful for this reason.

The fact that there was a 'life happens' extension was really nice as it meant that students didn't feel like they had to disclose personal information and withstand high levels of scrutiny when they required an extension, especially during a particular challenging semester. Not many other professors were quite so understanding which really set this course apart.

Dr. Soedirgo was very kind and helpful during my office hours appointment. It was very easy to get in contact with her to ask questions. Both Dr. Soedirgo and the TA for this course also left very thorough comments on my assignments which was really appreciated. Overall, Dr. Soedirgo seemed to really take student feedback into account when adapting the course to an online version.
